T. ROWE PRICE GROUP REPORTS PRELIMINARY MONTH-END ASSETS UNDER MANAGEMENT FOR AUGUST 2018

BALTIMORE (September 13, 2018) - T. Rowe Price Group, Inc. (NASDAQ-GS: TROW) today reported preliminary month-end assets under management of \$1.09 trillion as of August 31, 2018. Client transfers from mutual funds to other portfolios, including trusts and separate accounts, were \$1.6 billion in August 2018 and \$2.1 billion for the quarter-to-date period ended August 31, 2018. This brings total client transfers for the year-to-date period ended August 31, 2018, to \$15.7 billion.
